

# Supplemental Statistics

The statistics on the following three pages are provided to give a "feel" of Hanover County. The charts on this page focus on the people of Hanover. The chart immediately below shows that the County is steadily growing, and those who are moving to Hanover are relatively young, and enjoy increasing incomes and decreasing unemployment. The chart also confirms the County's commitment to a strong educational system. Despite a rapidly increasing school population, the ratio of students to instructional positions is decreasing.
