

The Hanover County Sheriff's Office is seeking the community's assistance in identifying the suspect or suspects involved in ten break-ins of businesses in Hanover County between September 6, 2007 and September 21, 2007. Additionally, one business was vandalized during this time-period in what could have been an attempted break-in.

All of these businesses are in close proximity to each other with forced open doors as the method of entry except for Primo Pizza, CiCi's Pizza, Coffee, Fudge & Nuts and Ginger Red Asian Bistro. In those break-ins, the suspect removed the glass from the front door of each establishment using methods common in the glass removal and installation industry.
