## Budget Payment Program: 2012 Personal Property Taxes

Attached are Twelve (12) coupons for use in making installment payments on your personal property taxes, so that you can minimize the final amount due on February 5, 2013.

At your option, you can make a payment any month(s), February through November. Use all twelve coupons, or only the ones you want. The amount of each payment is also entirely up to you.

**Please remember that all prior taxes must be paid in full to start this program.**

Although all vehicles, boats and other personal property have not been valued for 2012 by the County's Commissioner of the Revenue, you can still estimate your taxes for 2012. Vehicles generally decrease in value about 10% per year. Hanover's personal property tax rate for 2011 was \$3.57 per hundred dollars of property value.

As with your annual tax payments, any amount received will be applied to your total account, not a specific vehicle. Overpayments will be credited to your future tax bills.
