**HANOVER COUNTY, VIRGINIA  
 DEPARTMENT OF PUBLIC WORKS  
 SURETY BOND**

KNOW ALL MEN BY THESE PRESENTS: That we, \_\_\_\_\_

 obligated by this bond dated \_\_\_\_\_, to pay Hanover County, Virginia (“County”),  
 a political subdivision of the Commonwealth of Virginia, the sum of \_\_\_\_\_  
 \_\_\_\_\_ (\$ \_\_\_\_\_). Heirs, executors, administrators, successors,  
 and assigns of the Principal and the Surety are also obligated to pay the designated sum. The Principal  
 and the Surety waive and homestead exemption related to payment of this obligation.

This bond shall be in effect for a period of one year from the date hereof and shall automatically  
 renew from year to year thereafter, unless and until ( \_\_\_\_\_  
 \_\_\_\_\_) shall give ninety (90) days prior written notice to County Engineer,  
 Hanover County, P. O. Box 470, Hanover, Virginia, 23069, by certified mail, return receipt requested, of  
 intent to terminate same at the expiration of the ninety (90) day period. This bond shall also be  
 terminated upon the County Engineer ( or Designee) giving written release to ( \_\_\_\_\_  
 \_\_\_\_\_) stating that he has well and truly performed and fulfilled the obligations  
 of the agreement.

The condition of the above Obligation is such, that if the Principal complies with the provisions  
 of the Hanover County Code relating to erosion and sediment control, and all orders, requirements  
 decisions, determinations, rules, and regulations made pursuant thereto, and completes erosion and  
 sediment control measures as described on a plan dated \_\_\_\_\_, by \_\_\_\_\_  
 \_\_\_\_\_, consisting of pages 1 through \_\_\_\_\_, and any approved  
 amendments, for property located at/described as \_\_\_\_\_  
 this obligation shall be void; otherwise it shall remain in full force and effect.

If Principal fails to complete its obligations, the County shall notify the Principal and Surety. If  
 such obligations are not completed by the Principal or Surety, or their agents within 15 days after date of  
 notification by the County, the Surety shall pay the full amount of the bond, or such lesser amount as  
 may be demanded by the County, to the County, within 30 days of the date of initial notification referred  
 to above. The amount payable may include administrative or other costs.

Notification required by this Agreement shall be effective if given by registered or certified mail, return receipt requested, to the PRINCIPAL in the name and at the address below; to the SURETY in the name and at the address given below; provided that change of address shall be effective if given in accordance with this paragraph. Any notice to the COUNTY shall be given to the Hanover County Public Works Department, P. O. Box 470, Hanover, Virginia 23069-0470. The Principal agrees to notify the County immediately of any change of legal status or address.
